Complete set up by January 31, 2025.

Last day to place orders with Edwards Lifesciences is February 7th, 2025. Place orders with enableCV starting Monday, February 10, 2025.

Edwards Lifesciences will be spinning off its enableCV business into a new company in early 2025. The mission of this new company is to bring continued innovation that enhances cardiovascular surgical procedures and techniques. enableCV's product portfolio consists of devices that enable minimally invasive surgical approaches, as well as cannulae, all of which are used and respected by surgeons worldwide. 4. **When do I stop placing orders with Edwards and start placing orders with enableCV?**

 - The products in Appendix A will not be available through Edwards Lifesciences after February 7th, 2025.
 - Any orders placed with Edwards beginning Monday, February 10th will be rejected through GHX.
