

## **Subject: Contact Information Changes for 3M Health Care Company**

Dear Valued Customer,

Thank you for your support as we continue to prepare for the planned spin-off of the 3M Health Care business (the "Health Care Business"). The purpose of this letter is to inform you of a change in the Health Care Business's email address domain, and request that you update your records accordingly.

While the Health Care Business continues to be part of 3M and governed by the policies and procedures of 3M until the spin-off, we have transitioned employee and other customer-facing email addresses, effective January 29, 2024. We have summarized the changes below and **ask that you update your records accordingly.** 

- Health Care Business employee email addresses have transitioned to @solventum.com. In most
  cases, the email prefixes remain the same. For example, if a Health Care Business employee address
  was previously <a href="mailto:name@mmm.com">name@mmm.com</a>, they can now be reached at <a href="mailto:name@solventum.com">name@solventum.com</a>. There will be
  a temporary redirect in place to minimize disruption, but we ask that you note this change and
  update your records accordingly to ensure seamless communication with Health Care Business
  employees.
- Centralized customer contact points for Health Care Business customer service, complaint intake,
  and invoicing have changed. Please see the chart below for detailed changes. If you use any of these
  group inboxes below from the left column, please note the new inbox address in the right column.
  If you do not use any of these inboxes, please disregard.

The new name represents how the independent health care company will focus on solving big health care challenges and emphasizes the tremendous impact it can make on the world.
