Product Supply Update

Dear Valued B. Braun Customer,

We are excited to share more positive developments in our ongoing efforts to restore normal supply and strengthen support for your clinical needs.

Effective August 15, 2025, we will remove allocations from the final 9 product codes in our IV Solutions and Injectable Drugs portfolio. Our entire portfolio of IV Solution and Irrigation products are fully available with no restrictions or allocations.

We are also retracting the previous communication sent on May 16, 2025, regarding product code S8004-5264. At that time, we advised sourcing alternatives due to supply constraints. With supply now available, that guidance is no longer necessary.

We know the IV Solution market disruption that began in the last quarter of 2024 caused significant hardship across the nation. We are excited that we could significantly ramp up production across our two IV manufacturing plants and do our part in supporting customer and patient needs nationwide.
