UPDATE: Product Allocations for U.S. IV Products - Hurricane Impact on Baxter's North Cove, NC Facility

Dear Valued Customer:

As communicated on the Baxter website on January 28, we continue to make strong progress at North Cove and have now restarted all of the site's 10 manufacturing lines. While some lines require additional time to ramp up production, we currently expect to be producing at pre-hurricane levels across the plant in the first quarter of 2025.

We are pleased to share specific changes in allocation levels for seven top volume groups of product codes that will increase to 110% effective February 18, 2025. These increases in allocation levels are described in Tables 1 and 2 below and are consistent for Baxter's direct customers and distribution partners. Please note that there is a typical 1 to 2-week lag time for product to flow through the full distribution network after allocation changes are implemented.

If your facility is a designated children's hospital or has received an approval through the pediatric allocation exception process, your allocation levels will increase to 110% as listed in the Tables 1 and 2.

Allocations for your facility are determined based on historical ordering from March 1, 2024 to August 31, 2024.

As seen in Table 1, the allocations refer to **groups of product codes**, meaning customers may receive a combination of product codes to reach the set allocation level for that product group.

As seen in Table 2 on page 2, allocation levels are assigned to the Baxter U.S. product codes (which begin with "2B") and <u>not</u> the temporary importation product code(s) denoted by an asterisk. Temporary importation product codes can be utilized as a substitute for their corresponding Baxter U.S. product codes. Please work with your Baxter representative if you would like to order temporary importation product codes.
