#### <u>UPDATE: Product Allocations for U.S. Solutions & Clinical Nutrition Products</u>

Dear Valued Customer:

As a result of the steady progress at North Cove, we are pleased to share that **effective immediately**, we have removed allocations on **11 highly utilized Product Codes** listed in bold in Table **1.**<sup>1</sup> These changes are applicable to Baxter's direct customers and distributor partners. We have asked our distributor partners to remove allocations on these Product Codes to their end customers.

We also anticipate removing allocations on virtually all the IV Solutions Product Codes manufactured at this facility as listed in Table 1 on or by May 13, 2025.

Below is summary of notable advancements related to North Cove that has helped us achieve these key milestones and will help support your facility's return to normal practices:

- All North Cove manufacturing lines are producing at or above pre-hurricane levels of output
- Baxter is carrying over 120% of pre-hurricane inventory levels for North Cove products at our distribution centers
- Baxter has 8 weeks of inventory on top 11 Product Codes that represent 85% of IV Solutions usage within U.S. facilities, at our distribution centers
- In March, we shipped over 2 million units of product made in North Cove to support our distributor partners' replenishment goals

In addition, we have made significant investments across our other manufacturing sites to increase overall capacity as well as run more efficiently to drive increased output, resulting in the following allocation changes:

# • Effective immediately:

- Allocation is removed on 2B0043, Mini Bag Plus quad pack, 0.9% Sodium Chloride Injection, 100ML.
- o Allocations are removed across all Product Codes for Intravia Empty IV Bags as listed in Table 2.
- o Allocations are removed for several ExactaMix Clinical Nutrition Product Codes as listed in Table 3.

### Effective May 6:

Allocations will increase to 125% for Mini-Bag Plus single packs as listed in Table 4.

#### Effective May 27:

o Allocations will be removed across all Product Codes for Irrigation Pour Bottles as listed in Table 5.

Allocations for all Product Codes are determined based on historical ordering from your facility from March 1, 2024 to August 31, 2024. Please note that there is a typical 1 to 2-week lag time for products to flow through the full distribution network after allocation changes are implemented.
