Dear Valued Customer:

As you may recall, to help mitigate IV Solutions shortages related to Hurricane Helene, Baxter worked with the U.S. Food and Drug Administration (FDA) to obtain FDA authorization to temporarily import and distribute certain IV Solutions products from Baxter's global manufacturing network. These product codes that were authorized for temporary importation and distribution by Baxter are listed in Table 1.

Effective October 31, 2025, inventory of these temporary importation codes will be depleted and no longer available for sale.

Please update your ordering systems to the Baxter U.S. Product Codes, which begin with "2B". as listed in Table 2. Supply of these Product Codes is readily available to order through Baxter and your distributor partner.

Thank you again for your efforts during and after this 1000-year storm. Your willingness to collaborate throughout this difficult time on a solution to continue providing exceptional patient care allowed us to deliver product from nine global manufacturing plants to support you in these efforts.
