This letter is to inform you of updated PGII certified weights for Monoject™ PGII containers in the 2, 12, 18, and 30 gallon sizes. The newly certified weights will be updated on the label per Department of Transportation (DOT) regulations and Code of Federal Regulations Title 49, part 178.6.

See Table 1 for the impacted item numbers and updated certified weights. Please review these changes with the teams managing final disposal of PGII rated containers at your facility.

The new maximum weight claims are listed below for reference:

- 2 Gallon Containers: 3.2kg
- 12 Gallon Containers: 8.4kg
- 18 Gallon Containers: 10.1kg
- 30 Gallon Containers: 23.7kg
