## SUBJECT: Small Volume Quad-for-Single Pack Substitutions for Sodium Chloride and Dextrose IV Solution Presentations

Dear Valued Customer.

ICU Medical is experiencing significant demand increases for our 50 mL and 100 mL 0.9% Sodium Chloride Injection, USP and 5% Dextrose Injection, USP product presentations due to the ongoing and dynamic IV Solution supply market conditions. Moreover, our small volume single pack inventory is continuing to recover from delays in overwrap availability due to Hurricane Helene impact on a critical supplier.

Customers should be aware that in order to maintain our 105% allocation level for ICU Medical customers with purchase history, effective immediately through March 31, 2025, ICU Medical, in collaboration with its trading partners may fulfill their orders with 4:1 (quad) in place of 1:1 (single) product configurations where possible to receive their total single and quad small volume bag monthly allocation.
