NOTICE: New CURLIN® IV Administration Sets Arriving Soon

Dear Valued Customer,

This notice is to inform you of an update for CURLIN Administration Sets. Moog is transitioning away from the 340-XXXX CURLIN Administration Sets (340 Series) and launching a new family of CURLIN administration sets: the 380-XXXX CURLIN Administration Sets (380 Series). **These new 380 administration sets will have all the same features and configurations as the current 340 administration sets**, but with some enhancements (see "Enhancements" below for more detail). After launch of the 380 administration sets, the 340 administration sets will no longer be available. *

*except for 340-4115 and 340-4133, which will continue to be orderable for use with CURLIN 6000 only

Timing:

We will no longer accept orders for the 340 Series administration sets after October 31st, 2025. After this date, you will need to order the 380 Series administration sets. From now until October 31st, 2025, you must continue ordering the 340 Series administration sets. Any orders placed for 380 administration sets before this date will not be accepted *unless* you are a CURLIN 8000 customer.

For planning purposes, please consider that while we will no longer accept new orders for the 340 administration sets after October 31st, 2025, we will continue fulfilling orders for the 340 administration sets that were placed on or before that date. There may be a limited time where you receive a mix of both 340 Series and 380 Series administration sets if you have open orders for the 340 Series awaiting fulfillment after October 31st, 2025.

Enhancements:

- Backwards compatibility: The 380 administration sets will be available for use in both the CURLIN 8000, CURLIN 6000, and CURLIN PainSmart pumps.
- Easier set loading: the yellow Free-Flow Protection housing will have a longer arm to assist in loading the set into the pump.
- 96-hour set life: the 380 administration sets are validated for up to 96 hours of use with the CURLIN 8000. Note: when using the 380 administration sets with the CURLIN 6000 or CURLIN PainSmart, they are validated for 72 hours.

New Filters:

The 380 administration sets with filters (both 0.2 and 1.2 micron) will have a different brand of
filters than the 340 administration sets. The function is the same, however, priming instructions
are DIFFERENT. Please be sure to read the <u>priming instructions included in the packaging for
each set</u> and educate your end users accordingly.



Ordering Process:

When the 380 Series administration sets are released into the market, the ordering process will remain the same as the current ordering process. Please continue to order your sets through your distributor or directly through Moog Medical Customer Service.

When placing an order, the prefix for each new administration set will be '380' (the prefix for the current administration sets is '340'). The suffix for each updated product code will remain the same as the suffix in the current product line. For example, the current product code <u>340</u>-4114 will become <u>380</u>-4114. Refer to the table below for a list of the new 380 product codes that are equivalent to 340 product codes or new codes altogether. Equivalent product codes are in green text, new codes are in blue text.

- Pricing for the new 380 administration sets will be consistent with your current pricing for equivalent 340 administration sets.
- Any orders placed for 340 administration sets after October 31st, 2025, will automatically be fulfilled with the 380 administration set equivalent.
- To ensure sufficient supply to all customers during this transitionary period, we will not honor any large stocking orders outside of typical order volumes for either 340 or 380 administration sets.

The 380 administration sets will be backed by the same industry-leading clinical and customer support teams, which are available to assist customers and patients with any question or concern 24 hours a day, 7 days per week, any day of the year.
