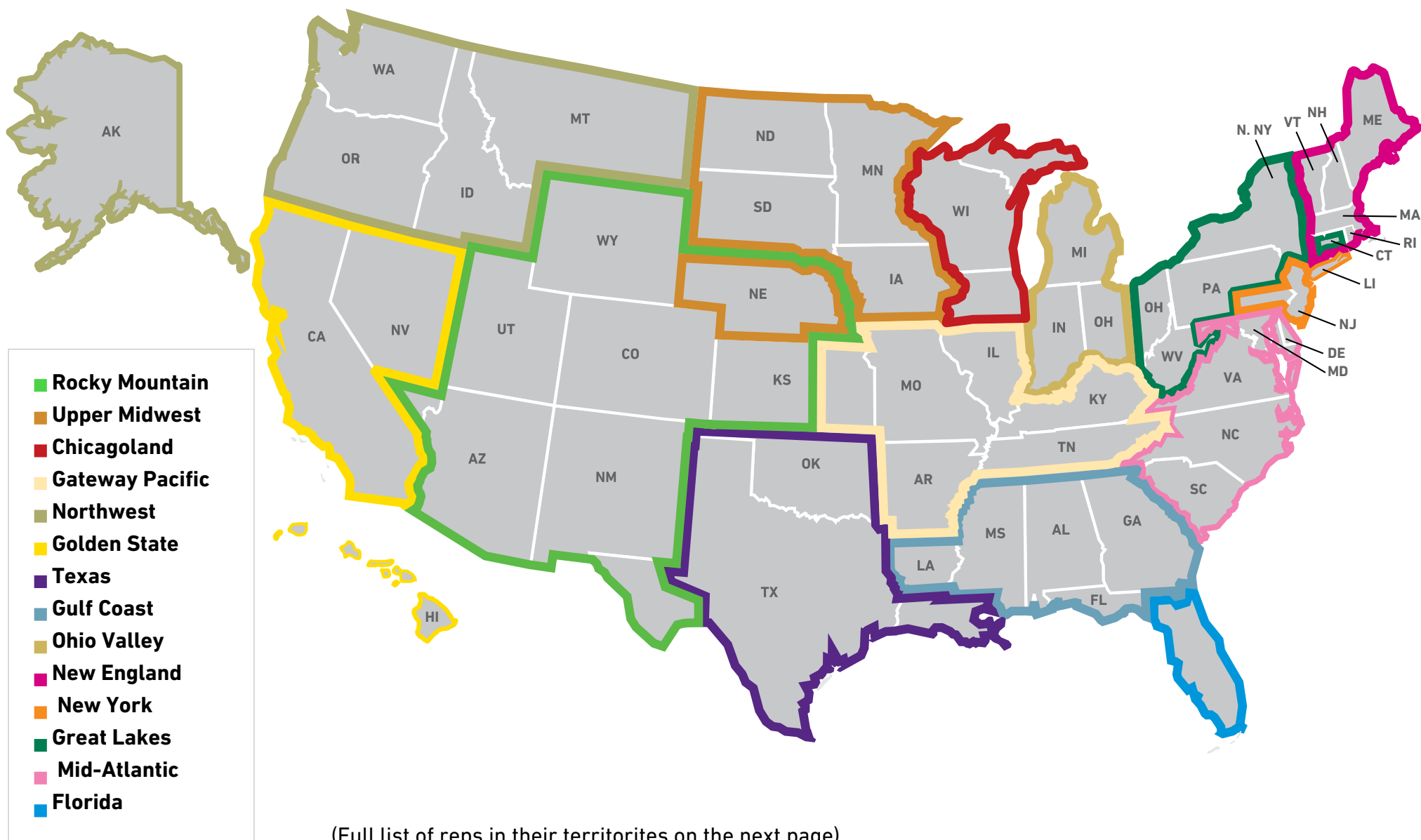


Enterprise Territory Map
