Packaging Redesign for Compleat® Portfolio in Cartons

We heard directly from clinicians about challenges they had with our prior design and incorporated color differences and icons to help with identifying products within similar segments and understanding when to use each product. We pride ourselves on the fact that our Compleat® Portfolio has something for everyone, whether you want vegan, plant-based, animal-based or organic options and options with or without fruit and vegetable ingredients.

To increase accessibility to nutritional information about our products, we have added quantitative values for Calcium and Potassium to the Beneprotein® Protein Powder Nutrition Facts Panel. Please note we are not adding Calcium or Potassium to the formula. These values reflect the levels of naturally occurring minerals found in whey protein.
