Nutren® 1.5 - Update to Total Calories on the Label

Nestlé Health Science previously shared updates regarding the protein and fat sources in our Nutren® 1.5 formula. There were no changes to the amounts of total protein, fat, carbohydrates, or vitamins and minerals in the product. However, as part of this update, the total calories per serving on the label were adjusted to reflect mathematical rounding. As a result, labeled total calories increased from 375 kcal per 250 mL/carton to 380 kcal per 250 mL/carton. Labeled total calories for the 1L UltraPak increased from 1500 kcal/L to 1520 kcal/L.
