Nestlé Health Science is committed to providing high-quality, science-based nutrition formulas. In the spirit of continuous improvement, we would like to share the following updates to our product portfolio.

COMPLEAT® Organic Blends and COMPLEAT® Pediatric Organic Blends

In our ongoing effort to improve our portfolio, we have new formulations that will replace our current **COMPLEAT® Organic Blends** and **COMPLEAT® Pediatric Organic Blends** formulations. These formulas will continue to provide all the nutrition you have come to depend on from **COMPLEAT Organic Blends**, plus provide improvements with our packaging, ingredient sourcing and processing method to better ensure supply and availability of our formulas, and create a smoother, more consistent formulation.

Through this relaunch we are enhancing our packaging with the addition of an easy-to-open, spouted pouch that can be reclosed and sealed. We've heard your feedback that our existing tear open packaging has been a pain point for you and your patients, and we are excited to now offer this feature.

In addition, we have made ingredient sourcing changes and nutrient changes to account for the natural variability of nutrients in the organic ingredients and blenderized whole foods. These changes result in minor differences in the percentage of total calories provided by protein, fat and carbohydrates. The formulas continue to meet the dietary reference intake (DRI) requirements for key vitamins, minerals and protein and continue to provide an excellent option for those patients seeking blenderized whole foods to support nutritional needs and feeding tolerance. We have enclosed a comprehensive side-by-side to illustrate the macronutrient and micronutrient changes as well as a comprehensive specification sheet to outline the changes to pallet configuration and case dimensions.

On the front of the canister (seen below)

- Removal of 'New Name, Same Formula' yellow burst
- Addition of B Corp logo

On the back of the canister (not pictured below)

- New 1-800 number for consumers with 24/7 access to our Baby Experts
- New QR code leading to consumer website (www.extensiveha.com)
- New QR code 'Escanee para español' leading to Directions for Preparation and Use in Spanish
- Certified Halal logo

In addition, the Gerber® name and logo have been removed from the outer case (seen below.)

After careful consideration and evaluation, we want to inform you that we will be discontinuing the following products, ThickenUp® (starch-based) food and drink thickeners. We will continue to offer ThickenUp® Clear (xanthan gum-based) instant food and drink thickening powder. ThickenUp® Clear provides many benefits vs. ThickenUp® (starch-based), including:

- Remains clear when mixed in water
- Tasteless and odorless
- Does not over-thicken with time
- Maintains its prepared viscosity in the presence of salivary amylase

ThickenUp® Mixing Information

The amount of ThickenUp® (starch-based) thickening powder needed to reach a desired consistency varies by the type of beverage. Transitioning to **ThickenUp® Clear** (xanthan gum-based) offers the benefit of 1-2-3 scoops mixing directions for a more simplified approach. For example, 1 scoop mixed with 4 oz of many different types of beverages provides an IDDSI level 2 consistency. Two scoops mixed with 4 oz provides an IDDSI level 3 consistency. Another benefit is less powder of **ThickenUp® Clear** is needed to thicken the same volume (4 oz) of a beverage vs. **ThickenUp®** (starch-based) powder.
